

How do I become a donor of Camp Jorn YMCA's Heritage Endowment?

The Heritage Endowment is composed of individuals from all backgrounds, communities and walks of life who have made an outright or planned gift to Camp Jorn YMCA's Endowment Fund in one of the following ways ...

An outright gift of cash —

In this way, each donor benefits from both the good that will be done and current income tax savings.

An outright gift of appreciated assets—

If you choose to contribute such items as stock or property owned for longer than one year, you would receive a charitable deduction equal to the current value of the assets while avoiding capital gains taxes.

A life insurance gift—

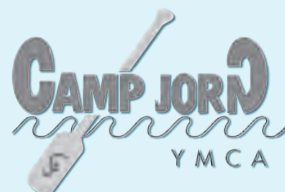
Naming Camp Jorn YMCA as a primary or even secondary beneficiary of your insurance policy paves the way for a large future gift. Should you wish to contribute a life insurance policy that is no longer needed to protect current beneficiaries, you could realize substantial income tax deductions.

A gift through your will—

You may wish to consider including Camp Jorn YMCA in your will or living trust. In this way, a fixed amount, specific asset or percentage of your estate may be set aside as a bequest and qualify for estate deduction.

A gift made through a charitable trust or annuity—

Creating a charitable trust or annuity provides life income for yourself and/or others. With all or a portion of your gift eventually directed to Camp Jorn YMCA, you could receive a charitable deduction.

The initial purpose of the Heritage Endowment will be to build funds for the "Maintenance

An endowment of \$1.25 million at 4% will provide \$50,000 a year to help cover those costs.
