## Family Camp Registration Policies

1. Families attending successive family camp sessions, have first right to reserve their same accommodation unit. Deadline is Feb. 15<sup>th</sup>.
2. If a family vacates their cabin by not returning, then that unit is open first to those families who are returning from prior year and wish to upgrade or change accommodation unit. If we do not know of your desire to change, we will fill all open cabins with new families on a first come basis.
3. After Feb. 15<sup>th</sup> deadline for prior family campers to register and reserve their unit and after existing family campers have been placed in requested cabin, then remaining units will be filled on a first come basis.
4. Families staying for the entire session will be given preference over those registering for a limited stay. If you would like to make a change, we will put your request on a wait list and will call you after May 1st with available cabin options. When possible we will make every attempt to accommodate changes.

We hope that we can adequately accommodate all families who wish to attend a Camp Jorn YMCA family camp session. We appreciate your help with this process!

**Waiver Information:** I understand that although Camp Jorn YMCA has taken reasonable steps to provide my family with appropriate training, equipment and skilled staff for their experience, I acknowledge that some inherent risks cannot be eliminated without destroying the unique character of these activities. **Payment Plan and Agreement:** It is understood that a non-refundable, non-transferable deposit of **\$200 per family, per session** is required with registration to hold a cabin. If payment is late, only cash or a certified check will be accepted. The balance is refundable only if canceled one month prior to camp or for a bonafide medical reason and must be requested in writing to the Camp Jorn office. Refunds are not issued to families who choose to go home early.
